- Deposit must be sent with this application. Please send a Cheque of €500 payable to 'Archdiocese of Malta' by not later than the 15<sup>th</sup> of May 2018
- For youth under 30 years of age the final settlement of €300 must be made by the 2<sup>nd</sup> of June 2018. (For over 30 years of age the final settlement is €600).

- Cancellation of booking can only be accepted in writing and the following penalties will apply:

If cancelling before:	Penalty loss:

- In case of any increase in prices due to suppliers, pilgrims will be notified of the extra costs. MCYN & the Commissariat for the Holy Land are not responsible for the change in prices and will pass on these extra charges to the pilgrims.
- MCYN & Commissariat for the Holy Land reserve the right to cancel the pilgrimage if the quota of pilgrims is not reached. In this case all payments made will be returned.
- MCYN & Commissariat for the Holy Land are not responsible for any damages incurred during transport, extra charges of food and services incurred during the pilgrimage.
- Beverages including water are not including during any of the meals unless indicated otherwise. Consumption of food and beverages from minibars or other services used at any residence during the pilgrimage are at the expense of the pilgrim.
- Please make sure that all documents are valid with at least 6 months before expiry date.
- It is the responsibility of the pilgrim to advice MCYN & the Commissariat for the Holy Land of any medical conditions. MCYN & Commissariat for the Holy Land will do their best to help the pilgrim but cannot guarantee to offer any services and facilities required.
- Departure and arrival times may vary depending on the airline and the organisers are not responsible for any changes.
